

SUMMARY ANNUAL REPORT

For Epic Games Inc. Employee Benefit Plan

This is a summary of the annual report of the Epic Games Inc. Employee Benefit Plan, EIN 52-1853991, Plan No. 501, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Epic Games, Inc. has committed itself to pay certain self-insured Medical and Dental claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Prudential, Modern Life Inc., and National Union Fire Ins. Co. of Pittsburgh, PA. to pay Life Insurance, Long-term Disability, Accidental Death and Dismemberment, and Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$1,462,210.
